This program is only available to non-profit organization that provides human services on the south shore of Lake Tahoe, Carson City and/or Carson Valley. Up to 100 tokens or passes will be provided upon approval by the South Tahoe Area Transit Authority (STATA). An organization or subsidiary of the organization may only apply once a year and this program is subject to review by the STATA Board of Directors annually. These tokens and passes CANNOT be resold to the general public. Additional tokens may be purchased at a rate of \$1.50 per token.

If you are active, print the page and use that as proof. If you are not active, go to page 2 and follow the directions. If the verification of your status is not available at the time you submit your application, you must indicate the date on which you requested the verification and the estimated date it will be forwarded to the South Tahoe Area Transit Authority.
